The cryogenic capacity is 200 MMcf/d and refrigeration capacity is 145 MMcf/d. The cryogenic facility started in 1991 and was expanded in 1993 and 1997, the refrigeration facility was originally built in 1998 but was idled for several years until it was rebuilt and restarted in 2004. The depropanizer, debutanizer and butane splitter units were added during the 1990's, providing fractionation capacity of 9,500 barrels per day.
